

# 2012-13 Utah University Education Graduates Analysis

<b>Population</b>	Defined as any individual in CACTUS that was recommended for a license area of concentration during the 2012-13 academic year (9/1/2012 to 8/30/2013)
<b>License Area</b>	The attached data does not represent all license areas. Only the following license areas were included: Early Childhood Education (K-3), Elementary Education (1-8), Elementary Education (K-6), Preschool Special Education (Birth - age 5), Secondary Education (6-12), Special Education (K-12+). The following license areas were NOT included in this data, but would be available upon request: Administrative/Supervisory(K-12), Communication Disorders (K-12+), School Counselor (K-12), School Psychologist (K-12), School Social Worker (K-12), Speech - Language Pathologist.
<b>2013-14 Active LEA</b>	Defined as the LEA at which the individual was employed during the 2013-2014 school year. This included all data in CACTUS, not just public schools. It is possible for an individual in the population to have worked in multiple LEAs and would therefore be listed in the Active LEA by Recommending Institution multiple times. Please note that individuals employed at charter schools were combined into a single "Charter School" category. Similarly, individuals employed at various private schools were combined into a single "Private School" category. Please note that private school data in CACTUS does not include all private schools in Utah and is not as reliable as public school data.
<b>2012-13 Recommending Institution</b>	The Utah institution that recommended the individual for the license area of concentration.
