In 1954, the Utah Legislature authorized a "Voted Leeway Program"; in 1965, the name was changed to "Voted Board Leeway Program." In the current "State-Supported Voted Leeway Program," a local district may levy an additional property tax not to exceed ten mills (0.002000 per dollar of assessed value) with the approving vote of its people.

² Grand School District's Board-Approved Leeway was challenged by referendum and placed on the November 6, 1990, ballot; it passed.

³ Granite School District placed its Board-Approved Leeway on the November 6, 1990, ballot; it passed.

⁴ Weber and Nebo School Districts placed their Board Leeways on the November 6, 1990, ballot without invoking the Board Leeways; they both failed.

⁵ Pursuant to 53A-16-110 "Special tax to buy school building sites, build and furnish schoolhouses, or improve school property."

⁶ Additional 0.00600 implemented during FY 1999-00 school year (Tax Year 1999).

⁷ Cache School District increased its Voted Leeway from 0.000400 to 0.001600 on 3-Nov-98.

⁸ Morgan School District's Voted Leeway of 0.000250 would have expired 30 June 2005. Had this passed, the leeway would have expired in June, 2005.

⁹ Box Elder voted to raise Board Leeway to 0.000400 on 13-Sep-00

¹⁰ Millard School District added 0.000400 to an existing 0.000400 authorization on 7-Nov-00.

¹¹ Because Cache School District needed to exceed the Certified Tax Rate for their FY 2001-02 budget, they were required to resubmit the Voted Leeway referendum question of 11-3-98 for approval of a 0.001200 increase. The reconsideration passed. The approved ceiling of 0.001600 remains in place. [53A-17a-133 (4) (c)]

¹² North Summit School District Board of Education first voted to implement a Board Leeway on March 17, 1998; a tax rate of 0.000400 was levied for the first time during the FY 2002-03 Fiscal Year.

¹³ Jordan and Granite School District Boards of Education increased their total Voted and Board Leeway levies to 0.002000 with the elections of 4 Feb 2003.

¹⁴ Carbon School District Board of Education replaced its variable voted leeway ceiling of 16% of the Basic Program established on 16 April 1956 with a specific voted leeway tax rate ceiling of 0.001100 with an election on 4 Feb 2003.

¹⁵ Carbon School District Board of Education passed a resolution to levy a Board Leeway of 0.00188 for FY 2003-04 on 12 March 2003.

¹⁶ Nebo School District Board of Education increased their total Voted Leeway levy to 0.001200 with an increase of 0.000600 during the election of 3 Feb 2004.

¹⁷Wasatch School District Board of Education asked voters permission to increase their total Voted Leeway levy ceiling to 0.001600, from the existing ceiling of the rate that yields 10% of the district's Basic Program, during the election of 22 June 2004. The proposition failed.

¹⁸Wasatch School District Board of Education asked voters permission to increase their total Voted Leeway levy ceiling to 0.001600, from the existing ceiling of the rate that yields 10% of the district's Basic Program, during the general election of 2 November 2004. The proposition passed. For: 4,437/Against: 2,612.

¹⁹Morgan School District Board of Education asked voters permission to establish a Voted Leeway levy of 0.000800 during the general election of 2 November 2004. The proposition failed. For: 1,467/Against: 2,076.

²⁰Tooele School District did not implement this board leeway.

²¹Weber School District approved an additional authorization of 0.000466 for the Voted Leeway on June 27, 2006 to increase their levy to 0.001091. For: 6,316 (58.43%) Against: 4,494 (41.57%)

²²Grand School District's Voted Leeway election failed 1684 against – 1125 in favor with a 44.3% voter turnout.
