1. Negotiated rates are calculated utilizing the most current Annual Financial Reports (AFR) and other supplementary data as required by the U.S. Department of Education.

2. LEAs may elect to use a lower rate than negotiated with local governing board approval.

3. If an LEA elects to use a lower rate than negotiated, that rate must be applied to all programs with a similar rate type. For example, an LEA has a negotiated rate of 5% but elects to utilize 3% for the restricted rate. The elected 3% rate must be utilized for all programs that require/allow a restricted indirect cost rate recovery.

4. Utah Grants and rate calculation will always utilize the negotiated rate even if the LEA elects to utilize a lower rate.

5. LEAs are not allowed to utilize rates greater than the negotiated rate.
