

Foreword

This publication represents the combined effort of staff members at the Utah State Office of Education. It is intended to be a single-source review of education-related legislation from the 2012 Legislative Session. This publication is written for State School Board members, local school board members, charter school board members, superintendents, charter school administrators, and school business administrators. It may also be useful to other public education-related organizations and to State Legislators.

The main body of the publication reviews each education-related bill that was passed and identifies action that might be taken by the State School Board and district or charter boards to implement the requirements of the legislation. The publication also contains summary information on funding, bills not passed, and items from the Master Study List that may be addressed by the Legislature during the Interim Session or the 2013 Legislative Session.

This publication is a service of the Utah State Office of Education, but is not intended to convey any specific direction or assignments for action by the local education entities. Such requirements, if needed, will come directly from the Office of the State Superintendent. This publication is also not intended as a formal legal opinion or interpretation of legislative action.

2012 GENERAL SESSION SUMMARY OF LEGISLATION

H.B. 1 Public Education Base Budget Amendments (Newbold/Stephenson)

This bill appropriates funds for the support and operation of public education for the fiscal year beginning July 1, 2012, and ending June 30, 2013. The bill sets the value of the weighted pupil unit (WPU) initially at the same WPU value set for the 2011-12 fiscal year: \$2,577 for the special education and career and technology add-on programs; \$2,816 for all other programs.

USOE/State Board Action: Distribute funds

<u>Intent Language</u>: The Legislature intends that the State Board of Education allocate \$2,584,400 from the appropriation for "To and From School – Pupil Transportation" to support transportation costs at the Utah Schools for the Deaf and the Blind.

District/Charter School Action: NONE

<u>Funding:</u> This bill appropriates the following for fiscal year 2012-13:

- \$3,750,000 from the General Fund
- \$16,000,000 from the Uniform School Fund
- \$2,386,756,300 from the Education Fund, and
- \$1,114,454,100 from various sources as detailed in this bill.

H.B. 3 Appropriations Adjustments (Brown/Hillyard)

This bill supplements or reduces appropriations which were previously provided for the use and support of state government for the fiscal years beginning July 1, 2011 and ending June 30, 2012, and beginning July 1, 2012 and ending June 30, 2013.

USOE/State Board Action: Distribute funds

District/Charter School Action: NONE

Funding:

This bill appropriates the following for fiscal year 2011-12:

- \$9,270,200 from the General Fund, and
- \$675,900 from various sources as detailed in this bill.

• Of those funds, \$1,539,300 is appropriated to the State Board of Education Internal Service Funds—Indirect Cost Pool.

This bill appropriates the following for fiscal year 2012-2013:

- \$13,573,400 from the General Fund
- \$3,600,000 from the Education Fund, and
- (\$7,594,800) from various sources as detailed in this bill.
- Of those funds, \$1,070,000 is appropriated for public education for the following programs:
 - Library Books & Electronic Resources
 - Critical Languages & Dual Immersion
 - Teaching and Learning (to implement the provisions of *Youth Suicide Prevention*)
 - Professional Outreach Program
 - Informal Science Education Enhancement
 - Integrated Student and New Facility Learning

H.B. 7 Current School Year Supplemental Public Education Budget Adjustments (Brown/Hillyard)

This bill appropriates funding to school districts and charter schools for educator salary adjustments and child nutrition, and allows a school district or charter school to use the school district or charter school's remaining money received under the Education Jobs Fund program.

USOE/State Board Action: Distribute funds

District/Charter School Action: NONE

Funding: This bill appropriates the following for fiscal year 2012:

- \$2,662,000 from the Education Fund, and
- \$56,580,300 from various sources as detailed in this bill.

Effective Date: Immediate upon Governor approval

H.B. 12 Corrections Education Amendments (Wright/Stephenson)

This bill removes the State Board of Regents from provisions regarding the education of persons in the custody of the Utah Department of Corrections. Higher Education has not provided instruction for

inmates for several years. This change in Code reflects current funding and practice. It will not affect LEAs.

USOE/State Board Action: Assist the Department of Corrections in writing a report every three years.

District/Charter School Action: NONE

H.B. 15 Statewide Adaptive Testing (Hughes/Stephenson)

This bill requires LEAs to administer an adaptive test beginning in 2014-15. There is a requirement to have a 15-member parent committee review all adaptive test questions.

<u>USOE/State Board Action</u>: Adopt a computer adaptive test; establish a 15-member parent item review committee. Amend R277-402—Online Testing.

District/Charter School Action: Prepare to administer an adaptive test by 2014-15.

Funding: \$6,700,000 provided annually to the USOE

H.B. 19 (S1) State Issued Identification Numbers (Harper/Stevenson)

This bill prohibits a government entity from using a nine-digit number (meant to avoid the use of social security numbers) as a person's identification number. If such a number currently exists, the government entity must phase out such practice as it redesigns its information technology system.

<u>USOE/State Board Action:</u> Employee numbers, CACTUS numbers, student identifier numbers, etc., cannot be nine-digit numbers.

<u>District/Charter School Action:</u> Employee numbers, CACTUS numbers, student identifier numbers, etc., cannot be nine-digit numbers.

Funding: NONE

H.B. 53 (S1) Utah Education Network Amendments (Menlove/Hillyard)

This bill clarifies the governance of the Utah Education Network (UEN) by creating the Utah Education Network Board (which is the new governing board for UEN specifying the membership of the Utah Education Network Board), and by specifying the power and duties of the Utah Education Network Board.

<u>USOE/State Board Action:</u> Appoint four members representing public education to the Utah Education Network Board.

District/Charter School Action: NONE

Funding: NONE

H.B. 62 Provisions Regarding School Supplies (Powell/Osmond)

This bill allows elementary schools and teachers to provide parents with a list of suggested school supplies. It requires that specific explanatory language be included on supply lists and requires schools to provide equivalent supplies to all students free of charge.

USOE/State Board Action: This bill will require amendments to R277-407-School Fees.

<u>District/Charter School Action</u>: Districts and charters may need to make changes to local policies on the provisions of school supplies, and assure that statutory "notice" is included on any supply lists made available to parents.

H.B. 115 Peer Assistance and Review Pilot Program (Moss/Osmond)

HB 115 appropriates money for a pilot program to assist school districts with mentoring and evaluation of new and underperforming veteran teachers. The Peer Assistance and Review (PAR) pilot will be created to use "consulting" teachers in conducting regular evaluations, providing assistance, and making recommendations for continued employment. A PAR Joint Panel made up of equal parts teachers and administrators acts as the governing panel of a district's PAR Program grant money, which can be used to

hire consultants and fund additional stipends, equipment, and travel for consulting teachers, as well as to fund operational costs of the PAR Joint Panel and teachers enrolled in the program.

USOE/State Board Action:

- 1. Make rules specifying:
 - Procedures for applying for and awarding grants.
 - Criteria for awarding grants.
 - Reporting requirements for grantees.
- 2. Solicit proposals to participate in pilot from districts.
- 3. Determine awardees of grant based on Board criteria.
- 4. Report findings from pilot to Education Interim Committee.

District/Charter School Action:

- 1. Apply for pilot inclusion if interested.
- 2. If accepted, adhere to components of HB 115 and subsequent rule.
- 3. Provide data to the USOE for reporting to Board and Education Interim Committee.

Funding: One-time funding of \$300,000 non-lapsing

H.B. 128 School Community Council Revisions (Wright/Dayton)

This bill exempts school community councils from the requirements of the Open and Public Meetings Act and establishes requirements for the notice, agenda, and minutes of a school community council meeting. The bill also requires that school community council elections be conducted within the first 30 days of the school year and end no later than the 35th day of the school year.

<u>USOE/State Board Action</u>: Board Rule revisions to R277-491. Continue to train districts and councils on the requirements of the law.

<u>District/Charter School Action:</u> Ensure that schools provide notice of open school community council positions and conduct elections in a timely manner. Ensure that school community council meetings are conducted openly.

Funding: No funding needed.

H.B. 148 Transfer of Public Lands Act and Related Study (Ivory/Niederhauser)

This bill enacts the Transfer of Public Lands Act and provides that the state shall retain 5% of the net proceeds it receives and deposit those proceeds into the permanent State School Fund.

H.B. 149 Online Education Survey (Eliason/Osmond)

This bill provides for the establishment of a pilot online school survey system in which students, parents, and teachers evaluate schools.

<u>USOE/State Board Action</u>: This bill requires the State Board of Education to establish a pilot online school survey system, including surveys to enable students to evaluate teachers and school administrators; parents to evaluate teachers, schools, and themselves; and teachers to evaluate schools and school administrators. The State Board of Education must contract with a provider, through a request for proposals process, or develop a system to provide technology for the survey system; make rules establishing procedures for administering surveys or making available online access to surveys; analyze and aggregate survey data; publish aggregated survey data on its website; and make results available to school districts and school administrators.

<u>Intent Language</u>: The Legislature intends that at least \$30,000 of the appropriation (\$40,000) for Contracts and Grants be used for technology related to the pilot online school survey system created in Section 53A-1-410.

<u>District/Charter School Action:</u> Administer online student surveys of teachers; make available to parents online access to surveys which they may complete for their children's teachers and schools.

Funding: \$40,000

Effective Date: May 8, 2012; appropriation takes effect July 1, 2012.

H.B. 156 Public Education Program Amendments (Newbold-Bramble)

This bill amends, adjusts, or eliminates several public education programs. Specifically, the bill:

- 1. Requires the State Board of Education to provide a general financial literacy test-out option.
- 2. Amends funding for foreign exchange students to include them in student growth counts for the purpose of adjusting certain appropriations.
- 3. Eliminates an NESS program to help teachers obtain endorsements and licenses (grant run through Regional Service Centers by Henry Jolley).
- 4. Eliminates a requirement that the State Board make rules on the distribution and care of textbooks.
- 5. Eliminates outdated language and provisions on career ladders.
- 6. Eliminates a requirement pertaining to the allocation of WPU funds between licensed and classified school district employees.
- 7. Eliminates funding language for three programs that no longer exist: the Families, Agencies, and Communities Together for Children and Youth (FACT) program; the Local Discretionary Block Grant; and a 2001 school district hold harmless program.
- 8. Eliminates the requirement to provide higher compensation to classified employees in comparison to other employee groups.

<u>USOE/State Board Action</u>: Change the foreign exchange website, change the pupil accounting handbook, and inform LEAs of the availability of the General Financial Literacy competency-based test.

<u>District/Charter School Action:</u> Change rules or procedures associated with foreign exchange students, provide information to students regarding the test-out option for general financial literacy, and review implications of changes regarding WPU funds and employee groups.

H.B. 197 Grants for Math Teacher Training (Edwards/Stephenson)

This bill appropriates money for math teacher training programs.

<u>USOE/State Board Action</u>: The Board of Education must make rules establishing criteria for awarding grants for math teacher training programs.

District/Charter School Action: NONE

Funding: \$500,000

H.B. 206 (S2) Curriculum Options for Secondary School Students (UCAT) (Ipson/Valentine)

This bill contains two fairly unrelated provisions:

First—The bill gives greater control to the secondary school student, or the parent or guardian of a minor student, in determining if the career and technical education goals of the student are better achieved by attending a UCAT facility.

Second—The bill allows for secondary students served under this section of the Code on a campus of the UCAT to be counted in the average daily membership (ADM) of the sending school district or charter. This is funded by reducing the value of the WPU from \$2,848 to \$2,842.

<u>USOE/State Board Action</u>: Whereas the bill specifically notes that 1,373 WPUs are allocated for this purpose, the State Board intends to amend R277-419—Pupil Accounting—to define qualifying students statewide with the intention that the number of qualifying students will be approximately 1,373 WPUs. The rule may apply to all students leaving high school campuses to attend class at another state-funded institution.

<u>District/Charter School Action</u>: Districts and charters will continue to count qualifying students in their ADM. If districts and charters choose to send non-qualifying students to a UCAT facility, they will be required to prorate the ADM for those students based on the time they are actually in school in the district or charter facility.

<u>Funding:</u> No new funding was allocated for this bill. To account for the additional 1,373 WPUs now allowed to be counted in ADM, the value of the WPU was reduced from \$2,848 to \$2,842. This reduced value applies to all WPUs except those WPUs already valued at \$2,607 (SPED and CTE Add-on).

<u>Effective Date:</u> Districts and charters will be allowed to count all students attending a UCAT facility in their 2011-2012 ADM. For 2012-2013 and moving forward, only qualifying students will be allowed to be counted in the ADM.

H.B. 213 (S1) School Community Council Member Qualifications (Perry/Osmond)

This bill requires that the parent or guardian members of a school community council total at least two more than the school employee members of the council. The bill also requires that the number of parent or guardian members of a council who are not educators employed by the district exceed the number of parent or guardian members of the council who are educators employed by the district. The bill allows for a school employee to serve on a community council at a school where the employee is not employed.

<u>USOE/State Board Action</u>: Potential Board rule revisions. Continue to train districts and councils on the requirements of the law.

H.B. 311 Electronic Meetings for Charter School (Daw/Urquhart)

H.B. 363 (Veto) Health Education Amendments (Wright/Dayton)

This bill requires human sexuality instruction or instructional programs to teach and stress:

- 1. The importance of abstinence from all sexual activity before marriage and fidelity after marriage as the only sure methods for preventing certain communicable diseases.
- 2. Personal skills that encourage individual choice of abstinence before marriage and fidelity.

Allows local school boards to adopt abstinence-only instructional materials or opt out of providing human sexuality instruction.

USOE/State Board Action:

- 1. Develop and/or recommend an abstinence-only curriculum (in consultation with parents) for courses that include instruction on human sexuality.
- 2. Instructional materials must include a parent component to assist parents in providing human sexuality instruction to their children.
- 3. Provide abstinence-only professional development for all human sexuality teachers.

District/Charter School Action:

- 1. Local Educational Agencies may choose not to provide sex education to their students.
- 2. Advance parent permission is required for abstinence-only human sexuality instruction.
- 3. Teachers may not discuss homosexuality or contraceptive methods or devices.
- 4. Teachers are prohibited from answering spontaneous questions regarding homosexuality or contraceptive methods or devices.
- 5. LEA Human Sexuality Instructional Materials Committees may choose to adopt materials not on the USOE list as long as they support abstinence-only instruction.
- 6. LEAs must provide abstinence-only professional development for all human sexuality teachers.

H.B. 367 (S2) Trust Lands Amendments (Noel-Dayton)

The bill also establishes timelines for the Nominating Committee and requires that the SITLA Director keep the School Children's Trust Director informed on matters important to beneficiary rights and interests.

H.B. 389 Student Education Occupation Plan Amendments (Newbold/Stephenson)

This bill makes minor changes to the Student Education Occupation Plan (SEOP). It defines an SEOP and specifies that the SEOP is be to initiated early in the student's secondary education to help guide students in course selection and preparation to post-secondary options.

Student Education/Occupation Plan (SEOP) now means a plan developed by a student and the student's parent or guardian, in consultation with school counselors, teachers, and administrators that (1) is initiated at the beginning of grade 7, (2) identifies a student's skills and objectives, (3) maps out a strategy to guide

a student's course selection, and (4) links a student to post-secondary options, including higher education and careers.

USOE/State Board Action: Amend R277-462—Comprehensive Counseling and Guidance Program.

District/Charter School Action: LEAs may need to also revisit and/or rewrite local SEOP policy.

H.B. 397 Charter School Start-up Amendments (Dee/Stephenson)

This bill provides grants to charter schools for expenses for planning and implementation; allows the State Charter School Board to use a portion of the money for monitoring, professional development, and technical assistance; and establishes a mentoring program for new and existing schools.

<u>USOE/State Board Action:</u> Write rule (R277-481) for the mentoring program; create start-up and implementation grant application and reporting requirements; and provide financial monitoring, professional development, and technical assistance to governing board members and staff of new charter schools.

H.B. 491 Midterm Vacancy Amendments (Dougall/Valentine)

This bill amends the Utah election code by requiring municipalities and local school boards to interview potential appointees for vacancies filled other than through a regular election in public meetings. It prohibits any discussion of filling midterm vacancies or temporary absences in a closed meeting.

H.B. 500 Education Reporting Efficiency Amendments (Wilcox/Osmond)

This bill requires the State Board of Education to meet with LEA representatives to determine how to modify or eliminate reporting requirements to reduce the time school district and charter school personnel spend in completing reports. The State Board is to consider eliminating Board reports that are redundant or reporting where time and effort exceed the value of what is being reported, and to recommend elimination of reports required in statute that are redundant or of little value.

<u>USOE/State Board Action</u>: Meet with LEAs to discuss reporting requirements. Make changes, if needed, to State Board reports. Recommend changes, if needed, to state statute reporting requirements. Report to the Education Interim Committee by October 2012.

H.B. 501 (S1) Youth Suicide Prevention (Hutchings/Mayne)

Licensed employees are required to complete two hours of professional development on youth suicide prevention within the period of their license renewal cycle.

<u>USOE/State Board Action:</u> Adopt or develop sample materials to be used by LEAs for professional development on youth suicide prevention.

<u>District/Charter School Action:</u> LEAs must provide professional development on youth suicide prevention to all licensed employees. All licensed employees must complete two hours of professional development on youth suicide prevention within license renewal cycle.

H.B. 503 (S2) Construction Amendments (Morley/Niederhauser)

This bill amends the Utah Code relating to construction contract terms, bond and lien claims. Language defines the term "differing site conditions clause" and requires contracts for school building construction to contain this clause. The bill requires that, unless otherwise specified in a lawful contract between the owner and the person making a bond claim, the interest rate applicable to a lien or bond claim must have the statutory rate of 10% per annum. It defines that a temporary labor service company, a professional employer company or organization, a union trust fund, or any other entity that provides or collects for labor not be exempt from providing preliminary notice of a payment bond claim or a lien.

<u>USOE/State Board Action</u>: USOE may have to change their board rules and the "School Building Construction and Inspection Resource Manual (Resource Manual)," to align with changes to state statute.

<u>District/Charter School Action</u>: If current Board policies do not reflect the need to include: "differing site conditions clauses;" the statutory rate of 10% for liens or bond claims; and/or the ability to include provisions by the contractor of operations, maintenance, or financing in design-build or construction manager/general contractor contracts, they may need to update such policies.

H.B. 513 Early Intervention Program (Newbold/Stephenson)

This bill creates an early intervention program (Title 53A, State System of Public Education) that is targeted to at-risk students and delivered through a voluntary enhanced kindergarten program. It also requires the State Board of Education to select technology providers through an RFP process to provide interactive computer software for literacy or mathematics instruction and assessment in grades K-1.

<u>USOE/State Board Action:</u> An RFP for interactive technology providers must be created, subsequent respondents evaluated, and one or more vendors selected. Data must be collected on student performance related to computer software use and reported prior to November 1, 2013. Amend R277-481—OEK.

<u>District/Charter School Action</u>: Districts and charter schools that receive funding based on the number of identified at-risk students (based on free and reduced-fee lunch count) must provide a voluntary enhanced kindergarten program that uses research-based practices designed to close performance gaps for at-risk students.

\$2,500,000 for an interactive computer software program for literacy or mathematics instruction and assessment in grades K-1

H.B. 514 (S1) Public and Higher Education Technology Amendments (Newbold/Stephenson)

This bill directs the State Board of Education, Salt Lake Community College, and the Utah College of Applied Technology to provide a high school educational program on the use of information technology, and specifies the components of an educational program on the use of information technology, including a curriculum, online access, classroom instructional software for student use, certification (for students), professional development, etc.

<u>USOE/State Board Action</u>: Provide a high school educational program on the use of information technology to impart instruction on skills and competencies essential for the workplace and requested by employers. The components include a curriculum; online access to the curriculum; instructional software for classroom and student use; certification in skills and competencies most frequently requested by employers; professional development for teachers; and deployment and program support, including integration with existing curriculum standards. It is to be available to high school students, faculty, and staff.

District/Charter School Action: LEAs will need to include this program in their course schedule.

H.J.R. 1 (S2) Sustainable Schools Joint Resolution (Wheatley/Morgan)

This bill encourages the State Board of Education and school districts to consider ways to establish schools that promote a healthy environment for students as well as being energy efficient in their operations and development.

<u>USOE/State Board Action</u>: Provide a copy of the resolution to all school district school boards. USOE will have to incorporate language in the "School Building Construction and Inspection Resource Manual (Resource Manual)" to support language found in the resolution.

S.B. 2 Public Education Budget Amendments (Hillyard/Brown)

This bill provides for budget increases and decreases for the use and support of certain state education agencies; provides for budget increases and decreases for programs that support school districts and charter schools; provides a distribution formula for the appropriation for Teacher Supplies and Materials; provides intent language; modifies the guarantee dollar amount per weighted pupil unit for the voted local levy and board local levy programs; sets the estimated minimum basic tax rate at .001665 for fiscal year 2012-13; and establishes the value of the weighted pupil unit for fiscal year 2012-13 at \$2,607 for the special education and career and technology add-on programs, and \$2,848 for all other programs.

<u>USOE/State Board Action</u>: Study student-based funding allocation model for CTE, and report by October 2012. Develop a comprehensive performance measurement plan for the MSP, and report during the 2013 General Session. Address the costs and benefits of the Board's early retirement incentive plan. Develop job-specific, outcome-based performance measures, and report by December 2012 to the Public Education Appropriations Subcommittee. Perform cost-benefit analysis of the activities and programs of the USOE, and report before November 2012 to the Public Education Appropriations Subcommittee. Adjust rules and possibly formulas to distribute an additional \$3,000,000 to NESS.

<u>Intent Language:</u> The Legislature intends that the State Board of Education study a student-based funding allocation model for the Career and Technical Education (CTE) Add-on program that takes into account the relative cost difference associated with providing various CTE programs and does not exceed current funding levels appropriated for the program, but may include an annual adjustment for student enrollment growth. The Legislature intends that the State Board of Education report to the Education Interim Committee, the Public Education Appropriations Subcommittee, and the Executive Appropriations Committee by October 2012 the potential allocation models developed by the State Board of Education.

The Legislature intends that enrollment in charter schools for the 2013-14 school year may increase up to 7,100 students over the projected enrollment of 51,421 for the 2012-13 school year.

The Legislature intends for the State Board of Education to develop a comprehensive performance measurement plan for the Minimum School Program that identifies specific program-level outcome and evaluation metrics. This plan shall include program-level performance detail on all restricted and semi-restricted programs, as outlined in the 2011 In-Depth Budget Review. The State Board of Education shall report the details of this plan to the Public Education Appropriations Subcommittee during the 2013 General Session.

The Legislature intends that the State Board of Education address the costs and benefits of its Early Retirement Incentive Pay Plan and its open Other Post-Employment Benefits plan that allows individuals to accumulate health insurance benefits at retirement. The State Board should report its finding to the Public Education Appropriations Subcommittee by November 2012.

The Legislature intends that the Utah State Office of Education work with the legislative fiscal analyst for public education in developing job specific outcome based performance measures and report these measures to the Public Education Appropriations Subcommittee by December 2012.

The Legislature intends that the Utah State Office of Education work with the legislative fiscal analyst for public education in performing cost-benefit analysis on the activities of the programs within the Utah State Office of Education—Administration line item, and report the results to the Public Education Appropriations Subcommittee before November 2012.

The Legislature intends that the Department of Health, the Utah State Office of Rehabilitation, and the Utah State Office of Education (Special Education) use funds previously transferred to support the Utah Developmental Disability Council (UDDC) information and referral phone/website to instead provide direct client services to individuals with disabilities. The Legislature further intends that the UDDC, as a federally-established and federally-governed agency, use its federal funds to support its information and referral phone/website.

The Legislature intends that the Department of Health, the Utah State Office of Rehabilitation, and the Utah State Office of Education (Special Education) use funds previously transferred to support the Access Utah program to instead contract with a private human services directory database entity to provide a free information and referral service statewide for individuals with disabilities.

S.B. 48 Mission of Public Education (Jones/Gibson)

S.B. 64 (S1) Public Education Employment Reform (Osmond/Gibson)

SB 64 amends 53A-1-301 to clarify the role of the State Board in appointing the state superintendent, and outlines duties of the state superintendent with regard to a statewide education strategy for system-wide improvement, accountability, and reporting.

The Public Education Human Resource Management Act is amended to provide general guidelines, requirements, and procedures for the development and implementation of employee evaluations, including:

- 1. Annual evaluations of each school district employee (exemptions can be made for temporary or parttime employees).
- 2. Summative ratings that differentiates among four levels of performance.
- 3. Provisions for independent review of an educator's summative evaluation.
- 4. Specific steps for remediating deficiencies determined through evaluation process.

Provisions for new employee compensation and termination procedures are also outlined in this bill.

USOE/State Board Action:

- 1. Make rules (R277-531—Public Educator Evaluation Requirements) in accordance with SB 64, including required components of employee evaluations, timelines for implementation, reporting mechanisms, and privacy and protection of individual data. These provisions include creating specific rules for both teacher and administrator evaluations.
- 2. Report progress on implementation to Education Interim Committee as requested.
- 3. Make rules for performance compensation as required in 53A-8a-601.

District/Charter School Action:

- 1. Local boards, in consultation with its educator evaluation joint committee, will develop an educator evaluation program based on the rules set forth by the Board. Districts can adopt or adapt the USOE model or develop their own aligned with Board requirements established in rule. Full implementation of teacher and administrator evaluation systems must occur no later than the 2014-15 school year.
- 2. Districts will include orderly termination policies and procedures, as well as standards related to developing and implementing a plan of assistance for career employees whose performance is

unsatisfactory. Nonrenewal or termination of a career employee's contract for unsatisfactory performance is more detailed in 53A-8a-503.

- 3. Transference of employees with unsatisfactory performance is restricted and can only be approved by the local school board.
- 4. Implement employee compensation system aligned with Board rule and annual evaluation system no later than 2015-2016 school year.

S.B. 81 Paraeducator Funding (Mayne/Litvack)

This bill provides funding to Title I school improvement schools to hire paraeducators to assist in teaching.

S.B. 93 (S1) Retention Proceeds Revisions (Jenkins/Morley)

This bill modifies provisions relating to retention proceeds under a construction contract. It outlines retention proceeds limits and how this money must be held separately in an interest-bearing account, along with how this money must be accounted for, and limits the amount a local school board may retain until a school construction project is completed and accepted by the board up to 5% of the contract price. It also adds counties, cities, towns, school districts, local districts, special service districts, and other political subdivisions to the definition of public agency. Language in the bill does not specifically address requirements for charter school construction retention.

<u>USOE/State Board Action</u>: If current State Board rules are contrary to changes outlined in this bill, such rules would need to be updated.

<u>District/Charter School Action</u>: School districts who do not currently hold retention proceeds for the benefit of contractors and the subcontractors in an interest bearing account, and/or have retention proceeds in excess of up to 5% will need to change their policies to align with changes in state statute.

S.B. 97 Grants for Online Testing (Osmond/Wright)

This bill provides one-time matching funds for LEAs to pay for the technology needed to implement an online summative test system, an online adaptive test system, or both by the 2014-15 school year.

<u>USOE/State Board Action:</u> Establish rules, R277-402—Online Testing:

- 1. Establishing procedures for applying for and awarding grants.
- 2. Specifying how grant money shall be allocated among school districts and charter schools.
- 3. Requiring reporting of grant money expenditures and evidence showing that the grant money has been used to implement online testing.
- 4. Establishing technology standards for an online adaptive testing system.
- 5. Requiring a school district or charter school that receives a grant to implement an online adaptive test system by the 2014-15 school year.
- 6. Requiring a school district or charter school to provide matching funds to implement an online test.
- 7. Assuring that student identifiable data is not released.

- 2. May not use federal funds to provide the matching funds.
- 3. May not impose a tax rate above the certified tax rate for the purpose of generating revenue to provide matching funds.

S.B. 138 (S1) Health Insurance Mandate Accountability Amendments (Weiler/Vickers)

This bill amends the Accident and Health Insurance Policy chapter of the insurance code and defines what constitutes a mandate. The bill also requires the Legislature to fund state mandated insurance changes. It specifically excludes from the definition of mandates the provisions of the Federal Health Care Mandates.

S.B. 151 (S2) Students at Risk of Academic Failure Study (Stephenson/Hughes)

This bill directs the Education Interim Committee to study students at risk of academic failure as it relates to (1) funding the demand for Carson Smith Scholarships, (2) funding to assist students who score below proficiency or are economically disadvantaged, (3) programs in other states to assist at-risk students, and (4) other initiatives to assist at-risk students.

NOTE: The original SB 151—Student Opportunity Scholarships—was a bill to provide qualifying students scholarships to attend private schools through tax credit donations to scholarship-granting organizations. SB 151 2nd Substitute, the bill that passed, is considerably different from the original SB 151.

S.B. 153 (S2) Procurement Amendments (Niederhauser/Brown)

This bill recodifies and amends the Utah Procurement Code and becomes effective May 1, 2013. The bill's language describes requirements and procedures relating to procurements by public entities, including applicability and exemptions from certain provisions of the Procurement Code; duties and powers of the Division of Purchasing and General Services, the State Procurement Policy Board, the procurement advisory councils, the state chief procurement officer, and the Purchasing from the Persons with Disabilities Advisory Board. The bill's language addresses cancellations, rejections, and debarment; reciprocal preferences and purchase from community rehabilitation programs; bid security and bond requirements; contracts and change orders; construction procurement and contracts; architect-engineering services; limiting information selection committee members may have; situations in which an informal cost-benefit analysis is required; allowing the use of multi-year contracts with restrictions; allowing construction manager/general contractor or design-build contracts to include provisions for obtaining a site for the construction project; small purchases; Requests For Information (RFI); multi-stage bidding; reverse auctions; transitional costs when changing providers; retention of records; contractors and subcontractors maintaining books and records related to the construction cost and pricing data of projects; addressing interaction between public procurement units; allowing circumstances in which an appeals board may be established; defining a "local public procurement unit" and the "head of a public procurement unit" (which includes school districts and charter schools, or designees for charter schools); making available to the public a written record of all procurements for an expenditure of \$50 or more; procedures, requirements, and limitations relating to controversies, protests, appeals, and judicial action; establishing ethical practice provisions relating to procurements and requiring compliance with the American Bar Association 2000 Model Procurement Code-Section 12; and amending existing and enacting new criminal provisions and penalties relating to procurements (including unlawful conduct, gratuities, dividing purchases, penalties and voiding contracts). The bill also clarifies that, to the extent that it does not conflict with potentially more restrictive requirements set forth by the State Board of Education, school districts and charter schools are required to follow the Utah Procurement Code.

<u>USOE/State Board Action</u>: If current State Board rules do not reflect changes outlined in this bill, they may need to update such rules.

<u>District/Charter School Action</u>: School districts and charter schools who have adopted state purchasing as their policy for procurement related matters may need to change their policies to align with changes to state statute. School districts and charter schools who have adopted their own policies for procurement related matters may have to change their policies to align with changes to state statute, ensuring they are at least as restrictive as the Utah State Procurement Code. In addition, charter schools may need to modify their policy language to include procurement requirements that weren't previously required, which now includes charter school designees.

S.B. 165 (S1) Redevelopment Agency Amendments (Weiler/Wilson)

The major clarifying provisions in this bill include allowing the taxing entity committee (TEC) to designate the base taxable value for an urban renewal or economic development project area budget—this is a new power of the TEC that gives agencies more latitude as they negotiate with the TEC in establishing how much increment will be kept by the agency and how much may be passed through to the taxing entities (the base tax year may not be a year that is earlier than the year during which the project area plan becomes effective). The notice creating a community development and renewal agency must also state that the agency's boundaries are coterminous with the boundaries of the community that created the agency.

The bill also clarifies that the number of years tax increment can be collected begins the first year the agency receives tax increment under the project area budget and that the number of years sales tax can be collected begins as indicated in the resolution or interlocal agreement of a taxing entity that establishes the agency's right to receive that sales tax. Also, the bill clarifies that inclusion of an estimate of tax increment to be paid to the agency for the calendar year ending December 31 and beginning the next January 1 is to be included in the redevelopment agency's November 1 report.

In addition, the bill requires overlapping urban renewal or economic development project boundaries to be reported to the TEC before its first meeting to consider approving the project area budget and before an agency collects tax increment from this newly created overlapping portion of a project area. The agency must also inform the county auditor of the respective amount of tax increment the agency is authorized to receive from that overlapping portion.

S.B. 178 (S1) Statewide Online Education Program Amendments (Stephenson/Daw)

This bill rescinds scheduled entry of the Electronic High School into the Statewide Online Education Program and requires that EHS courses be provided free of charge to students who are Utah residents (53A-2-201). It modifies fees paid for courses delivered through the Statewide Online Education Program based on course content, and program procedures (53A-15-1201 et seq.) to facilitate enrollment and clarify issues including release time (R277-419), IEPs, withdrawal, price negotiation, and FTE and enrollment "caps" in relation to online enrollment. The bill requires the program name, "Statewide Online Education Program," to be used in the dissemination of information on the program; permits a student taking an online course to take more than a full course load if allowed under local school board or charter school governing board policy; modifies requirements for reports on the performance of an online course provider; and provides for a declaration of intent to enroll in an online course.

<u>USOE/State Board Action</u>: The state superintendent must report noncompliance with program statutes to the State Board of Education, which shall take appropriate action to ensure compliance with program statutes. The State Board of Education must amend R277-726 consistent with changes in statute (53A-15-1201 et seq.), and the State Board of Education, including an employee of the State Board of Education, may not give preference to an online course or online course provider.

<u>District/Charter School Action:</u> LEAs must ensure that counseling staff and business officers are aware of revisions in program requirements and of program requirements generally.

S.B. 191 (S1) Accountability for School Attendance (Stevenson/McIff)

This bill clarifies the section of the Utah Code (53A-11-101.5) addressing compulsory education. Changes include: (1) a law enforcement officer acting as a school resource officer may issue a notice of compulsory education violation, (2) a truancy citation issued to a parent or guardian is no longer only under the jurisdiction of the juvenile courts, and (3) truancy citations may not be issued to a minor exempted from school attendance under Section 53A-11-102 or 53A-11-102.5.

USOE/State Board Action: This bill may require amending R277-607—Truancy Prevention.

<u>District/Charter School Action</u>: If a district or charter school desires to have school resource officers issue truancy citations, and local policy does not allow this, policies may need to be amended. Additionally, if local policies indicate that all truancy citations will be referred to juvenile court, these policies may need to be changed. District and charter schools will want to make their policies consistent with the Utah Code concerning students exempted from school attendance, as provided in 53A-11-102 or 53A-11-102.5.

S.B. 196 Software for Special Needs Children (Niederhauser/Hughes)

This bill directs the State Board of Education to contract with a provider selected through an RFP, and provide software and activity manuals to districts and charters that demonstrate a commitment to implement the program as prescribed by the provider.

<u>USOE/State Board Action</u>: The State Board of Education will begin immediately to develop an RFP and identify a provider that meets the qualifications outlined in the bill. Once a provider has been identified, districts and charters will be given an opportunity to participate in implementation of the chosen program.

S.B. 217 (S1) Math Materials Access Improvement Grant (Osmond- Dougall)

S.B. 223 Pledge of Allegiance Amendments (Osmond/Wright)

S.B. 248 (S2) Smart School Technology Act (Stevenson/Handy)

- 3. Peripherals and networking equipment, including a wireless network

- 8. Accessing and using online content
- 9. Ongoing technical support

The State Board of Education (with input from the committee) will:

- 1. Select schools to participate in the program;
- 2. Make rules for selecting schools to participate in the program; and
- 3. Evaluate the program (or contract with an independent evaluator) and report to the Education Interim Committee by October 2013.

S.B. 261 Charter School Revisions (Adams/Hughes)

S.B. 273 Surplus Property Amendments (McAdams/Brown)

The language of this bill modifies the provision relating to surplus school district property by allowing a broader group to acquire school district surplus property. The added purposes surplus property may be used by an eligible entity are (1) a facility for the promotion, creation, or retention of public or private jobs within the state through planning, design, development, construction, rehabilitation, business relocation within a county, city, or town; (2) as an office, industrial, manufacturing, warehousing, distribution, parking, or other public or private facility or for other improvements that benefit the state or a county, city, or town; or (3) a facility for an approved charter school applicant.

<u>USOE/State Board Action</u>: State Board may need to modify language in their Board rules to reflect changes in the bill to include the added eligible entities (including a facility for a charter school under Chapter 1a, Part 5, The Utah Charter Schools Act (53a-1a – Section 5)) that are able to acquire school district surplus property.

<u>District/Charter School Action</u>: School districts who do not include the three added groups able to acquire surplus property, will need to change their policies to reflect language in the bill. Charter schools may need to change their policies to include the ability to acquire surplus school district property.

S.B. 284 (S1) Concurrent Enrollment Amendments (Urquhart/Ipson)

SB 284 (S1) makes several changes to the Concurrent Enrollment Program. They are as follows:

- 1. The bill allows institutions of higher education to charge a student up to \$30 (\$15 for video conferencing courses) per credit hour for concurrent enrollment courses for which the student intends to receive college credit.
- 2. A secondary student may participate in a concurrent enrollment course and not pay if:
 - The student elects not to receive credit from an institution of higher education;
 - The class is a technology-intensive concurrent enrollment (TICE) course; and
 - The class is a gateway career and technology education course as defined by the State Board of Regents.
- 3. A state institution of higher education may only charge a concurrent enrollment student who qualifies for free or reduced-price school lunch partial tuition of up to \$5 per credit hour for each concurrent enrollment course for which the student receives college credit.
- 4. If a concurrent enrollment course is taught by a public school educator in a public school facility, a state institution of higher education may only charge up to \$10 per credit hour for the concurrent enrollment course for which the student receives college credit.
- 5. Concurrent enrollment courses have been defined as:
 - Introductory-level general education classes;
 - Career and technical education classes; or
 - Pre-major college-level courses at a state institution of higher education leading toward a certificate or degree.
- 6. Concurrent enrollment courses may be offered to high school students only by the state institution of higher education in the corresponding geographic service region, as designated by the State Board of Regents. LEAs are to contact the state institution of higher education in the corresponding geographical service region to provide a concurrent enrollment course. The higher education institution must respond to the request within 60 days on whether the institution chooses to offer the requested course.
- 7. If the state institution of higher education in the corresponding service region chooses not to offer the concurrent enrollment course, another state institution of higher education may offer the concurrent enrollment course.
- 8. Courses delivered through technology are not subject to the corresponding geographic service region requirement.
- 9. Tuition amounts may be discounted for students enrolled in multiple courses.

<u>USOE/State Board Action</u>: Board Rule R-277-713—Concurrent Enrollment of High School Students in College Courses will need to be revised to reflect the legislative changes.

<u>District/Charter School Action:</u> Concurrent enrollment policies and procedures will need to reflect the legislative changes.

Education Related Interim Study Items S.J.R. 3 – Master Study Resolution (Second number is the number in S.J.R. 3.)

- 1. 23. Academic Achievement Gaps—to study high quality preschool impacts on academic achievement gaps for at-risk students.
- 2. 24. Alternatives to GED—to study whether to issue high school diplomas to adults and those who do not graduate with the class instead of awarding a GED, to study the relative value between a high school diploma and a GED in the employment marketplace, and to study how to eliminate the GED in Utah and give diplomas instead, to give these students a higher value.
- 3. 25. Charter School Local Replacement Funding—to study whether school districts should contribute an amount equal to per pupil district property tax revenues for each resident student enrolled in a charter school.
- 4. 26. Charter School Mission and Online Education—to study whether a charter school student should be denied permission to take an online course through the Statewide Online Education Program because the charter school's mission is inconsistent with the online course.
- 5. 27. Concurrent Enrollment—to study the current program structure, cost, delivery, and coordination of public education and higher education.
- 6. 28. Credit for Teacher Professional Development in Technology—to study options for giving credit on the pay scale for teacher professional development in technology unrelated to college credit.
- 7. 29. Education Interim Committee Reports—to study whether one or more reports required to be submitted to the Education Interim Committee should be discontinued.
- 8. 30. Enhanced School Calendar Incentives—to study how to encourage school districts and charter schools to utilize their buildings year round to extend calendars, and how to offer teachers a 50% pay raise with no additional costs to taxpayers, with added benefits like paid vacations, holidays, and classroom aids.
