Foreword

This publication represents the combined effort of staff members at the Utah State Office of Education (USOE). It is intended to be a single-source review of education-related legislation from the 2014 Legislative Session. This publication is written for state school board members, local education agency (LEA) board members, superintendents, charter school administrators, and school business administrators. It may also be useful to other public education-related organizations and to state legislators.

The main body of the publication reviews each education-related bill that was passed and identifies action that might be taken by the Utah State Board of Education (USBE) and local district and charter school boards to implement the requirements of the legislation. The publication also contains summary information on funding and bills not passed.

This publication is a service of the Utah State Office of Education, but is not intended to convey any specific direction or assignments for action by the local education agencies. Such requirements, if needed, will come directly from the Office of the State Superintendent of Public Instruction. This publication is also not intended as a formal legal opinion or interpretation of legislative action.

2014 Legislative General Session Fiscal Highlights

Total Public Education Budget: \$3,996,948,800 (30 percent of the total State of Utah budget)

The total FY 2015 public education budget is \$3,996,948,800. Total funding in the Minimum School Program for FY 2015 is \$3,349,101,600. This represents a 4.7% increase from FY 2014.

Growth and Weighted Pupil Unit (WPU)

The Utah State Board of Education requested funding of actual growth to be added to the base budget and an increase of 2.7% in the value of the WPU. Growth was funded for MSP programs traditionally funded by the Legislature and the value of the WPU was increased by 2.5%

- 1. Enrollment Growth: \$61,200,000 ongoing and \$2,900,000 one-time
 Enrollment growth was fully funded for an estimated increase of 10,300 students next year.
- 2. The value of the WPU increased by **2.5%**, **\$62,500,000**.

2014 Interim Study List (S.J.R. 20) – Public Education Issues

- 1. "Ghost" Student Enrolling to study "ghost" student enrolling, recruitment, and funding between private companies and local education agencies.
- 2. Charter School Enrollment Capacity to study proposals regarding an "at enrollment capacity" charter school using or borrowing the unused enrollment capacity of another charter school.
- 3. Competency-Based Education to study issues related to competency-based education.
- 4. Competency-Based Education Model to study how to implement an educational approach in which students only advance upon mastery of subject matter.
- 5. Competency-Based Funding to study issues related to competency-based funding for higher education.
- 6. Contribution and Credit for Education Funding to study setting up a tax deductible fund within the Education Fund that would be credited to the donor's income tax. This would add to the Education Fund but would save 40,000 Utahns \$250 million in Alternative Minimum Taxes (H.B. 153).
- 7. Education Best Practices to study and determine the value of establishing an education innovation research and development effort in partnership with the private business sector.
- 8. Education Funding to study long-term funding options for public education.
- 9. Effective Principals and Teachers to study what makes a principal and a teacher effective.
- 10. Equalizing Capital Expenditures for School Buildings to study the disparity for equalization of capital expenditures for school buildings and maintenance and methods for equalizing capital expenditures for school buildings.
- 11. Guidance Counseling to study the use of online tools to improve the work of high school guidance counselors.
- 12. Guidance Counselor Independence to study requiring guidance counselors to be independent from Local Education Agencies.
- 13. Licensed Private Childcare and Prekindergarten Providers vs. Unlicensed Government Contracted Providers to study what is happening in the marketplace when unlicensed providers are contracting with government entities to provide day care or prekindergarten services, such as Local Education Agencies and districts that unfairly compete with licensed private providers.
- 14. Limited English Proficiency to study how to provide assistance to English Learning Students with limited English proficiency.
- 15. Low-Performing Schools to study incentives for low-performing schools.

- 16. Moving from STEM to STEAM to study adding the arts to Utah's Science, Technology, Engineering, and Math initiative (STEM) and funding, and review what it would take to centralize all Utah arts funding under the leadership of the STEM effort and move to a STEAM effort.
- 17. Development Impact on School Enrollment to study ways municipalities, counties, land developers, and school officials might coordinate planning to anticipate new housing developments' impact on school enrollment.
- 18. Objectivity in Delivering Scientific Content in Schools to study ways to ensure objectivity in delivering scientific content and encouraging student inquiry in public schools. The teaching of biological evolution, the chemical origins of life, global warming, and human cloning can cause controversy. These topics need to be addressed as such in schools, instead of as "fact."
- 19. Parent Trigger Law to study allowing parents to petition to change the management of a low-performing school.
- 20. Parental Leave for School Activities to study issues related to employers granting parental leave to attend certain school activities (H.C.R. 6).
- 21. Public Education to study issues related to public education funding.
- 22. Public Education Funding Needs to study the funding needs of public education (H.B. 403).
- 23. Public School Counselors to study the adequacy of current funding for public school counselors.
- 24. Quality Teaching Block Grant Funding to study the reinstatement of professional development quality teaching block grant funding.
- 25. Strategic Education Plan to study a research-based strategic education plan.
- 26. Student Fee Use to study the use of student fees for political purposes.
- 27. Student Privacy to study issues related to the release of public school student information (H.B. 169).
- 28. Sustainable Education Funding Model to study how to get to prerecession levels in education funding and a sustainable model for funding public education.
- 29. Teacher Colleges to study standards for teacher colleges.
- 30. Technology in Schools to study the use of technology in schools and the benefits and drawbacks, including a cost benefit analysis.
- 31. Costs of Records Under GRAMA to study when costs for records under the Government Records Access and Management Act should be waived.

- 32. Expungement of Administrative Disciplinary Action to study whether to provide for the expungement of agency records related to an agency licensee under certain circumstances (H.B. 124).
- 33. State Board of Elections to study the pros and cons of establishing a State Board of Elections (H.B. 144).
- 34. Cyber Bullying to study increased penalties for intentionally or knowingly using the Internet, a cell phone, or other devices to hurt or threaten an individual and endanger the individual's health or safety.
- 35. Religious Freedom Issues to study religious freedom for students, businesses, and churches.
- 36. School Planning and Zoning to study municipal and county land use provisions related to a school (H.B. 104).
- 37. Prohibition of Electronic Data Collection Assistance to study whether to prohibit cooperation between a federal agency that collects electronic data and any political subdivisions of the state (H.B. 161).
- 38. Postretirement Reemployment to study the costs associated with postretirement reemployment.
- 39. Retirement Contribution Rates to study and receive a presentation on preliminary retirement contribution rates.
- 40. School Bus Traffic Safety to study whether to allow school districts to contract for technology that will generate a recorded image of a motor vehicle driver passing a school bus when the red signal light is flashing, and to receive and submit the recorded image to law enforcement for possible investigation (1st Sub. H.B. 406).
