NOTABLE EDUCATION BILLS

Highlights of notable education-related bills

S.B. 127 Senator Ann Millner Representative Bradley Last

W H A T Establishes strategies and administers programs to improve early literacy outcomes in kindergartengrade three. Research suggests teachers and leaders matter more to student achievement than any other aspect of schools. The focus is to advance educator knowledge and skills in the science of reading to improve outcomes for Utah's students.

Numerous strategies are described in this legislation to create a comprehensive system of supports for improving early literacy proficiency. These include instructional supports, professional learning, system measures, and alignment with institutes of higher education.

Currently, **one in two students** in Utah reads at grade level at the end of the third grade. This trend has been relatively static for over a decade. To disrupt the norm and to achieve at least 70% of students reading at grade level by the end of third grade by 2027, our education system will leverage the opportunities within SB127 to orchestrate collective action to accomplish this goal.

H O W Through the design of high-quality professional learning in the science of reading for teachers, school psychologists, and administrators, and through effective coaching, change management, and a focus on collective efficacy.

Through statewide early literacy coaches to support Utah's lowest performing schools.

Through teacher preparation requirements to build foundational skills in the science of reading for teacher candidates.

Through partnerships to build community schools and increase family engagement.

If state funding for kindergarten is equal to or greater than 80% of the potential cost of adjusting the WPU weighting for a kindergarten student to a full WPU, the Public Education Appropriations (PEA) Subcommittee shall study the feasibility of transferring kindergarten funding to the WPU.

Current nationwide and statewide data show better outcomes for students who are enrolled in FDK.

National studies have shown that FDK:

- Reduced the achievement gap
- Showed greater outcomes (reading/math)
- Higher & faster growth rates (reading/math)
- Reduced the need for retention, remediation, and special education referrals
- Strengthened social and emotional skills


Research demonstrates that students who attend quality early-childhood programs like kindergarten are more likely to go on to college, earn more, and save for retirement as adults.

Qualifying grants are disseminated based on the greatest need considering the following: geography, socioeconomic need, the use of ongoing federal funds for FDK, and efforts to expand FDK.

The funding gives LEAs the ability to provide additional FDK classrooms.




States offering FDK as an option for **100%** of kindergarten students

School Turnaround

Program Revisions

Creates a voluntary option for schools to participate in school improvement efforts through application.

Creates a fixed number of schools that will be supported each year.

Shifts language emphasizing the positive aspects of participating in school improvement work. Prioritizes non-Title I Schools as recipients of support.

Due to limiting factors within the initial identification formula, only two schools were eligible to receive services in 2019, when schools were last designated.

Non-Title I schools were not able to access additional resources if their school continued to struggle.

More schools are eligible for support and services at different stages of their school-improvement journey.

State and federal school improvement initiatives are more aligned, serving more students.

Redefining how schools are designated for both the new voluntary and the mandatory state school improvement program makes room for more schools to participate.

An application process will allow schools to voluntarily participate in the school improvement program.

Use for Public Education

Distributes funds from the Public Education Stabilization Account to address capital and technology needs.

\$91.5 million is distributed to all districts and charters for local one-time funding priorities.

\$50 million is used to create the Small School District Capital Projects Fund to provide access to capital for small and rural school districts.

\$30 million is also provided for two Utah Schools for the Deaf and Blind (USDB) buildings.

Small and rural school districts have challenges accessing capital compared to larger school districts.

The Small School District Capital Projects fund allows for funding to be targeted to small school districts to address building and capital needs. The general distribution of funds helps all LEAs meet local needs.

A Capital Projects Evaluation Panel under USBE will recommend funding through the **\$50 million** Small School District Capital Projects fund.

Small school districts will be provided grants or low/no-interest.

The **\$91.5 million** is distributed to all LEAs.

- Charter schools divide 20% of the allocation by enrollment.

<u>HB 11</u>	Student Eligibility in Interscholastic Activities
Sponsors	Rep. Kera Birkeland and Sen. Curtis Bramble
Bill Summary	This bill prohibits students who's sex at birth is designated as male, as indicated on the student's birth certificate, from playing in female designated interscholastic athletic activities. If the prohibition is determined by a court of law to be illegal, the bill establishes a commission, including membership, that will determine the eligibility criteria for when a students who's sex at birth is designated as male may play in female designated interscholastic athletic activities. The bill further requires the commission to work with an athletics commission to establish the eligibility criteria. The Governor vetoed HB 11 and the Legislature approved a veto override on March 25, 2022. Shortly after the veto override, the Legislature passed HB 3001, Sex-designated Interscholastic Athletics Indemnification.
