


Utah Schools & Institutional Trust Lands System

Trust Lands Administration

Created in 1994, the Trust Lands Administration is an independent state agency responsible for managing trust lands throughout Utah.

Created in 2014, the School & Institutional Trust Funds Office (SITFO) manages and invests the Permanent Funds for each of Utah's 12 trust beneficiaries. Investment earnings are distributed to beneficiaries each year.

Serving Utah's trust beneficiaries, distributions help fund public and higher education, health and human services, and state reservoirs.


