SEATS Lock Date:

SB 137 Course Choice Empowerment:

Due to Senate Bill 137, private school students will now enroll in courses provided by a private contractor and, therefore, will not utilize the SEATS system. Registration for these students will be unavailable for the upcoming summer and 2025-2026 school year. Homeschooled students will continue to register through the SEATS system.

Senior Transcript Due Dates Notification:

Counselors will start requesting transcript due dates for seniors, and the date options are May 15 or May 20. Providers can view these dates by referring to the 'TranscriptDue' dropdown on the 'Manage CCAs' page in SEATS. Please check this list frequently to ensure that all specific requests are followed up on to guarantee the timely delivery of transcripts.

Upcoming SEATS Enrollment Closure Time:

On July 1, 2025, the USBE will change the closure time for course enrollments in SEATS to midnight on the final day of the providers' registration date. This change will give parents and students extra time on that last day to ensure they can complete the enrollment process.

You can become a Utah Fits All (UFA) Provider:

While students who receive UFA scholarships can no longer take classes through SOEP, you can become a UFA provider, thus allowing students to enroll directly in your program. To be considered an eligible school and be approved as a qualifying provider to accept scholarship funds, you must be a private school or LEA that operates independently, isn't an "agent" of the state, and is approved by the Utah Fits All customer support team.
